Terms and Conditions

1. The Rentor means the person who is responsible for the booking, namely the party leader who is stated as the lead surname on the booking form.
2. Affordable Family Holidays means the company responsible for renting the mobile home to the Rentor which is Portsmouth Properties Management Limited, registered office: 82A High Street, Cosham, Portsmouth PO6 3AJ.
3. The Mobile Home means the mobile home situated at plot 266, Nodes Point Holiday Park, St Helens, Ryde, Isle of Wight PO33 1YA.
4. Park Resorts means the holiday company situated at Nodes Point Holiday Park, St Helens, Ryde, Isle of Wight PO33 1YA.
5. The Party means all persons listed on the booking form who are staying staying at the Mobile Home.
6. £85 deposit required to secure booking and held in case of breakages, damage, excessive cleaning required, late departure, owners property missing and/or any other loss. The Rentor also agrees to check the inventory displayed in the caravan and will inform Affordable Family Holidays if any item/s is/are missing or damaged before or during their stay. The deposit will be returned to the rentor within 4 weeks following departure providing none of the aforesaid occur.
7. Full amount to be paid at least 1 calendar month prior to rental period or immediately if rental period is sooner. Failure to pay full amount on time may result in the Rentor's booked dates becoming immediately available to any other interested parties.
8. Cancellations will only be refunded if at least 31 days notice in writing is received by Affordable Family Holidays before rental period commences. Please note however, there is an £85 fee to cancel a booking.
9. Entertainment passes are available at reception from the holiday park and are not included in the booking with Affordable Family Holidays.
10. Park Resorts code of conduct and rules must be adhered to at all times, available by request at reception.
11. All refuse must be placed in dustbin bags and disposed of in the site's nearest refuse container before vacating the mobile home.
12. Check in time is from 4pm on date of arrival. Keys to be collected from reception for pitch no. 266. The Party must vacate the mobile home by 10am on the departure date. The date of arrival and departure dates are the dates booked on the booking form.
13. Lead guest must be over 21 years of age and responsible for these terms and conditions.
14. No same sex bookings will be permitted for a party of more than three and no hen or stag parties will be permitted to book.
15. Where the owner has placed an 'Owners Property' sign in the Mobile Home on an item or cupboard, the Rentor agrees not to touch such an item or anything in the cupboard.
16. Smoking is strictly not permitted in the mobile home, the Rentor will incur charges should there be evidence of smoking in the mobile home following the Rentor's departure.
17. Pets are not permitted in the mobile home, the Rentor will incur charges should there be evidence of pet mess or damage left by pet/s.
18. Parent/s and/or carer/s of infants, children and/or friends/relatives with disabilities are responsible for the safety and welfare of those in their care at all times in the mobile home.
